TRUSTEE BURNS STATED THAT THE USDA HAS BEEN WORKING ON THAT PROPERTY AND THAT WHEN THEY ARE FINISHED THE TOWNSHIP WILL ADDRESS THE ISSUE. TWO VIOLATION LETTERS HAVE BEEN SENT TELLING THEM THAT THEY CANNOT LIVE IN THE CAMPERS AND THEY ARE NOT ALLOWED TO HAVE THREE CAMPERS. THE ZONING INSPECTOR STATED THAT HE WAS INFORMED THAT THEY WOULD BE MOVING BUT THEY ARE STILL THERE. HE STATED THAT HE WILL MOST LIKELY HAVE TO TAKE THEM TO MEDIATION COURT. HE EXPLAINED THE PROCESS. TRUSTEES TOLD THE ZONING INSPECTOR TO BEGIN THE PROCESS AS SOON AS OFFICER PIKE SAYS THE USDA IS FINISHED ON THE PROPERTY. OFFICER PIKE WILL ACCOMPANY THE ZONING INSPECTOR TO THE PROPERTY SINCE HE HAS A RELATIONSHIP WITH THE RESIDENTS.

A CERTIFIED LETTER WILL BE MAILED BY THE FISCAL OFFICER TO WILLIAM MEEK REGARDING DEMOLISHING THE PROPERTY AT 312 BROWN ST.

TRUSTEES ASKED FOR UPDATE ON THE FAGLEY PROPERTY. INSPECTOR STATED THAT THEY ARE STILL GETTING ESTIMATES.

OFFICER PIKE- OLD BUSINESS

PRESENTED TREND REPORT. HE HAS NOT BEEN ABLE TO GET TOGETHER WITH THE DEPUTY IN CHARGE OF THE NEXTDOOR PROGRAM BUT WILL SET SOMETHING UP SOON. THERE HAS BEEN A LOT OF INTEREST SHOWN.

FIRE-OLD BUSINESS

THE HOUSE FIRE THAT OCCURRED ON SUNDAY WAS THE TOPIC OF DISCUSSION. THERE ARE FIVE FIREFIGHTERS SCHEDULED TO WORK ON THE WEEKENDS. THIS HAS BEEN THE PRACTICE FOR THE LAST FOURTEEN YEARS. TWO SQUADS WERE OUT WHEN THE STRUCTURE CAME IN LEAVING ONLY ONE PERSON AT THE FIREHOUSE. THE PROPERTY OWNER WENT TO THE FIREHOUSE INSTEAD OF CALLING "911". FROM THE TIME "911" RECEIVED THE CALL TO THE TIME THE FIRE DEPARTMENT WAS ON THE SCENE WAS FIVE AND A HALF MINUTES. THE FIRE WAS ALREADY OUT OF CONTROL AS THE CHIEF COULD SEE THE SMOKE FROM HIS HOUSE. NO ONE PERSON IS PERMITTED TO GO TO A FIRE BY THEMSELF; ONE PERSON CANNOT DO WHAT IT TAKES AT A FIRE SCENE. "LIVES FIRST; PROPERTY SECOND". CHANNEL 5 HAS BEEN VERY NASTY WITH THEIR COVERAGE OF THE INCIDENT. IT IS IMPORTANT THAT PEOPLE CALL "911" FIRST. DO NOT GO TO THE FIREHOUSE AND ASSUME THAT THERE IS A FULL CREW AVAILABLE.

CHIEF PRESENTED OCTOBER REPORT. 182 RUNS (49 FIRE/133 EMS)

ASSISTANT CHIEF LONG REPAIRED THE AIR RIDE SYSTEM IN THE 2005 AMBULANCE. IT IS NOW BACK IN SERVICE AND IS BEING USED AS A BACKUP. IT WILL BE SOLD WHEN THE NEW SQUAD IS PLACED IN SERVICE. THE NEW SQUAD SHOULD BE COMPLETED IN THE NEXT 25 DAYS. THE SCHOOL HAS GIVEN PERMISSION FOR THE SCHOOL LOGO TO BE DISPLAYED ON THE SIDES OF THE AMBULANCE. TRUSTEES APPROVED.

THE EMS/FIRE GRANTS HAVE BEEN WRITEN AND THEY ARE NOW WAITING FOR THE GRANTS TO BE OPENED SO THEY CAN BE SUBMITTED.
