HANNAH, ON BEHALF OF PAUL BRAASCH WITH THE WASTE DISTRICT, PRESENTED THE RESULTS OF THE WASTE COLLECTION BIDS. DUE TO CONFUSION OF THE WORDING, THE BIDS THAT WERE RECEIVED WERE CONSIDERED NON-BIDS AND THE BIDDING PROCESS WILL BEGIN AGAIN IN JANUARY OR FEBRUARY. THE BIDS WERE FOR ONE THREE-AYER CONTRACT WITH TWO CONSECUTIVE RENEWALS. TATE, FRANKLIN AND WASHINGTON TOWNSHIPS WOULD BE GROUPED TOGETHER IN THE BID.

KYLE AUCHE AND BRENT BALL FROM RUMPKE DISCUSSED THE PROSPECT OF TATE TOWNSHIP NOT PARTICIPATING IN THE BIDDING PROCESS AND GOING WITH RUMPKE. TYPES OF SERVICES WERE DISCUSSED. "HAND"SERVICE WOULD ONLY BE DONE IF THE TOPOGRAPHY OF THE RESIDENCE REQUIRED IT. EVERYONE WOULD HAVE THE SAME BASE PRICE AND HAVE RECYCLING. THERE WOULD BE NO CONTRACT. SENIORS GET A \$2.00 PRICE REDUCTION. UNDER THE AGGREGATION, THERE IS NO CHOICE OF COLLECTION SERVICE. RESIDENTS COULD OPT-OUT BUT WOULD NOT BE ALLOWED TO USE ANOTHER SERVICE. NO DECISION WAS MADE.

PROPOSAL FOR A CREMATION GRAVE SECTION WAS PRESENTED. THERE WOULD BE EIGHT GRAVES PER LOT WITH FLUSH MOUNT HEADSTONES. EACH GRAVE COULD ACCOMODATE A 14X14X14 CONTAINER. LOTS WOULD BE SOLD FOR \$200. THIS WOULD SAVE SPACE IN THE CEMETERY.
