ROAD/CEMETERY-OLD BUSINESS

CEMETERY REPORT WAS PRESENTED. 10 BURIALS, 6 FOUNDATIONS, 11 GRAVE SALES. TRUSTEES WERE ASKED IF THE ROAD DEPARTMENT COULD RENT A JACK HAMMER TO REMOVE THREE CULVERTS THAT ARE ENCASED IN CONCRETE. THE COST IS \$400 A WEEK. TRUSTEES APPROVED THE RENTAL.

THERE ARE STILL 7 CULVERTS TO REPLACE ON MOORE ROAD. BLACKTOPPING IS EXPECTED TO BEGIN IN AUGUST.

THE ROAD DEPARTMENT IS REQUIRED TO TAKE ANOTHER 140 TONS BUT COULD TAKE ANOTHER 60 TONS TO FILL UP THE SALT BARN. TRUSTEES DECIDED TO ONLY BUY THE REQUIRED 140 TONS AT THIS TIME.

A SUPER HEAVY DUTY TARP HAS BEEN ORDERED TO COVER THE SALT FOR THIS YEA.
