#### FIRE CHIEF- NEW BUSINESS

ISO EVALUATION REPORT. THE ISO RATING HAS IMPROVED FROM 4/9 TO 3/3Y. THIS WILL RESULT IN LOWER HOMEOWNER PREMIUMS. THE RATING IS BASED ON RESPONSE TIME AND MAN POWER. FIRE CHIEF WOULD LIKE TO HAVE AN ADDITIONAL 100 FIRE HYDRANTS INSTALLED THROUGH OUT THE TOWNSHIP. THE CURRENT COST IS \$3400 EACH.

THE FIRE STATION HAS BEEN OPENED BACK UP TO THE PUBLIC WITH INSTRUCTIONS. FIRE CHIEF RECOMMENDED THAT LEVI TROUTMAN BE TAKEN OFF HIS 1 YEAR PROBATION. TRUSTEES AGREED.

# ROAD/CEMETERY-NEW BUSINESS

REQUESTED TRUSTEES PERMISSION TO PURCHASE A THERMOMETER. APPROXIMATE COST WOULD BE UNDER \$100. A DAILY LOG WILL BE KEPT OF READINGS.

FIRE DEPARTMENT WILL CHECK WORKERS' TEMPERATURES ON TOWNSHIP CLEAN-UP DAYS. GLOVES WILL BE PROVIDED BY THE MAINTENANCE DEPARTMENT.

THE RETAINING WALL PROJECT WILL BE STARTED NEXT MONTH DUE TO THE CONTRACTOR HAVING A LABOR SHORTAGE.
